Driftless Area Land Conservancy is thrilled to welcome Jennifer Filipiak as our new Executive Director!


Jennifer joins Driftless Area Land Conservancy (DALC) from the American Farmland Trust (AFT) where she was the Midwest Regional Director. She worked directly with farmers and farmland owners, especially women landowners, to promote and incorporate the concept of conservation cropping systems – suites of practices such as cover crops, strip till and diverse crop rotations – that regenerate soil and improve profitability in any agricultural operation. She worked collaboratively with agricultural leaders, partner organizations, public agencies and state, local and federal governments to overcome barriers to adopt and advance common ground solutions for agriculture and the environment.

Filiapiak also led AFT's new "Women for the Land" national initiative which addresses the obstacles that women landowners, particularly those who do not farm but lease their land to farmers, face in accessing conservation programs and resources. The initiative combines research, on-the-ground projects and policy efforts to transform the agricultural landscape and develop a new voice for conservation.

"DALC is the land trust in Southwest Wisconsin where I live, and where my husband and I recently bought our own farm. We love this place, and are putting down roots. This new opportunity offers me the ability to work on the issues I'm most passionate about and have deeper impact here in my own community. I just couldn't pass up this new challenge. This new role is a growth opportunity for me professionally as well, but mostly it's an organization that I really connected with, having a mission that is focused on conservation (my roots), holistically integrated with agriculture," notes Filipiak.

Filiapiak brings more than 15 years of project management experience in conservation and sustainable agriculture having previously worked with organizations such as the Illinois Stewardship Alliance, The Nature Conservancy of Iowa, and the Lake County (Illinois) Forest Preserve District. Filipiak holds a B.S. in Ecology from Northern Michigan University and an M.S. in Wildlife Ecology from Southern Illinois University at Carbondale.

On behalf of the staff and board, we are thrilled to welcome Jennifer to our DALC family and are truly excited for what's to come. As always, thank you for your continued support and conservation ethic.



## BOTANICAL INSPIRATION

For David Kopitzke – botanist, artist, conservation easement holder and founding DALC Board member - the beauty and wonder of native vegetation goes far beyond the lush display of color that spring and summer bring: it extends to the minute details that often go overlooked and the subtle changes that transform vegetation throughout the entire year.

"So many wildflower guides focus exclusively on plants when they are in full glorious bloom. While I am attracted to flowers, I also find newly germinating seedlings, ripening fruit, fat roots and bulbs, and even shriveling leaves equally of interest. So my drawings are as likely to focus on these stages of growth and death as on blossoms themselves. My compositions try to indicate the full life cycle of plants even including underground structures and those that one is able to observe in winter," notes David.

Blending art and science has always been a part of David's background. In graduate school, he was hired as the botany department artist; when he retired, he submitted his work to the prestigious Hunt Institute for Botanical Documentation at Carnegie-Mellon.

This past June, David was selected by a committee at the UW-Madison Arboretum to showcase his drawings at the Arboretum Visitor Center. The exhibit, *Wisconsin Flora through the Four Seasons*, will open with a reception on **Sunday, January 12th from 1:00pm-3:00pm**. All are welcome and we encourage you to join us. David's artwork will be for sale and he is generously donating 80% of the proceeds to DALC. We hope to see you there!

## A DRIFTLESS GEM PROTECTED

This past February, thanks to a generous donation from Darrel Morrison and support from the DNR Knowles Nelson Stewardship Program, DALC acquired a special 20 acres of land tucked away on the southern edge of the Lower Wisconsin River Valley: *The Morrison Prairie & Forest Preserve*.

This scenic bluff property includes dry remnant prairie, oak woodlands and savanna, and mesic north facing woodlands. These diverse native communities, all of which are rated top priorities by the DNR, provide habitats for a number of rare or state-threatened species. From the top of the bluff, visitors can see a broad swath of the Lower Wisconsin River Valley to the north, as well as expansive views of the wooded hills and valleys to the south.

"Although a small site, Morrison contains a high quality remnant prairie bordered by restorable oak savanna and forest. These fragments of pre-settlement ecosystems are reservoirs

of biodiversity, that if protected and managed are critical to the conservation of rare species in the Driftless Area," notes Nate Fayram, Southwest Ecologist for the Wisconsin DNR.

DALC has secured funding to see through an ambitious but achievable series of needed habitat improvement measures. Fortunately, the plant and animal communities have persisted relatively intact, despite decades without prescribed fire, control of invasive species, or other management efforts. Restoration work has already begun, such as the clearing of invading red cedar off the core remnant prairie area in the winter of 2018.

The protection and restoration of Morrison complements existing conservation efforts in the area that are already solidified. The preserve is adjacent to an 800-acre property permanently protected by a conservation easement held by DALC, and less than a mile from a 630-acre property protected by a second

DALC conservation easement. It's also located less than a mile south of large tracts of land owned and managed by DNR as part of the Lower Wisconsin Riverway.

Thank you, Darrel, for creating a new land legacy in Southwest Wisconsin. Your generosity has established a refuge for rare plants and animals, and a place where people can truly connect to nature.

**Darrel Morrison is a distinguished landscape architect known for designing prairie-inspired gardens using native plants, and is a former professor at UW-Madison, University of Georgia, and Columbia University. One of his biggest projects is a partnership with David Letterman on Letterman's 30,000 acre ranch in Montana.**

# CONSERVING GRASSLANDS FOR WILDLIFE, WATER, FARMS, AND COMMUNITIES

Driftless Area Land Conservancy is pleased to host a network of grassland conservation partners with the fall 2018 launch of the Southwest Wisconsin Grasslands Network (SWGN). Partners include the Wisconsin Department of Natural Resources, the US Fish and Wildlife Service, The Nature Conservancy, and other national, state, regional and local agencies and conservation organizations. SWGN promotes conservation and grass-based agriculture practices that protect grassland bird habitat in a working agricultural landscape.

"[The Southwest grasslands] are vital for grassland birds, regal fritillary and monarch butterflies, and many other plants and animals that depend on grasslands for their survival. If we want to save these species, we need to engage many more people and restore many more acres in Southwest Wisconsin. **One organization or agency cannot do it alone**," notes Steve Richter, Director of Conservation Programs at the Wisconsin Chapter of The Nature Conservancy.

By honoring the historical union of agriculture and conservation in the Driftless Region, SWGN aims to create a region that is rich in healthy grasslands, successful working farms, clear-flowing streams, diverse wildlife,

and people who value and enjoy the landscape. To reach this vision, SWGN promotes grassland, prairie, and savanna restoration and grass-based agriculture through landowner outreach, community events, and financial and technical assistance. We are educating landowners and farmers who directly affect the regional landscape through farming and land stewardship practices.

DALC serves an integral role in the partnership by housing the SWGN Coordinator Cindy Becker and through sharing in the vast web of experts and champions of conservation that support this good work. 
If I only value prairie plants


